A summary on the state budget, health insurance, and you. The House and Senate have both passed bills that change the way health insurance decisions are made and bargained. Because the versions are different, they will have a conference committee to come up with one bill to vote on and if passed, go on to Governor Patrick to sign or veto. The House bill would allow municipalities to make changes unilaterally including to GIC. The Senate bill protects retirees and the very sick. It calls for coalition bargaining and a disputeresolution panel, and it includes fairer mitigation provisions for people with high out-of-pocket costs. The MTA recommends members contact their legislators and ask them to support the Senate language. While this is not the best,
