Here is a glimpse of what could be put into place for our new medical insurance. This year it can be mitigated by a fund of 25% of the savings, however it will last only one year by law and we really cannot discuss too much as we are in negotiations.

This is for Blue Cross/Blue shield as well as GIC, except GIC has extra payments for Out-of-Network.

Doctor Office Visit (Well Care) – Covered in Full

Doctor Office Visit/Medical Care- \$20 PCP, OB-GYN, Nurse Practitioner \$35 Other Network Providers

Yearly Deductible \$250 Individual \$750 Family

Yearly Out-of-Pocket Maximum-\$1,200 In-Patient \$600 Out-Patient

Emergency Room- \$100 Copay after deductible Co-pay waived if admitted Hospital Admission-\$300 or \$700 Copay

Surgical Day Care- \$150 Copay

Lab & X-rays- Deductible, then covered CAT Scans, MRI, PET Scans-\$100 Copay per date of service
